Bob Drake motioned to accept and Miriam seconded. Approved unanimously.

3. Approval of 2022 Annual Meeting Minutes

Frank, Miriam, Jenn reviewed minutes for 2022 annual meeting.

Voting options are Agree, Disagree, Abstain

Horst motioned to approve minutes of 2022 annual meeting, seconded by Bill. Majority agreed, no one disagreed, 4 abstentions.

4. Finances

<u>Lora Repp</u>, Canvass Coordinator,reported that we exceeded our Canvass Goal of raising \$70K in pledges. Pledges totalled \$74, 675

Budget Report (Cindy Enderby)

Revenue: fundraising, pledges, donations

Expenses: \$103, 575 (allocated \$24K from cash on hand to balance our budget).

We have \$94K cash on hand which will be tapped if we fall short this year.

Horst motioned to approve the proposed 2023-24 budget and Jenn seconded. 2 voted not to approve; no abstentions, majority approved the budget.

5. Minister's Report (Stacy Craig)

Stacy completed her ministerial training in Sept 2022 and sought a congregation to serve. She was working ½ time w/ Chequamegon Fellowship in Ashland, WI. She saw that Keweenaw Fellowship was on the list and was focused on many similar areas of shared interest. She decided on ¼ time with KUUF.

Over past 10 months, Stacy has accomplished the following, and much more:

- Worship & Rites of Passage
- Earth Day, new member ceremony, Service of the ancients, in-person services and an online service.
- All About Love book group
- Sharing Circles
- Outdoor education events
- Social Justice events
- Monthly article submitted to Daily Mining Gazette for religious page
- Meets monthly w/ Board President

This arrangement has worked extremely well, due to KUUF organizational structure. Carbon footprint is a challenge with her travel.

Stacy was cautioned not to 'overdo it'; be sure to have a support system Stacy was thanked for her contributions to the Fellowship during the past year.

Discussion of Article 2:

We fund UUA. It works when delegates from all Fellowships attend General Assembly (GA) June 21-25. KUUF has no delegates registered to attend.

Created Article 2 Commission to review 8th principle (anti-rascist liberatory theology; love is our guide). Article 2 needs to be approved two years in a row in order to be adopted. 270 individual congregations have voted at their annual meetings to adopt 8th

principle. If Article 2 is adopted into the By-Laws, then there would no longer be any principles.

KUUF straw poll vote in favor of Article 2: Majority approved 1 against 1 abstention

Consideration of 8th Principle

Should KUUF adopt/approve the 8th principle? Some people feel that by articulating 8th principle, we recognize the need to address racism in explicit terms.

Voted whether to continue work on the 8th principle Majority supported 4 opposed 1 abstention

6. Committee Reports

Individual committee chairs had the opportunity to share accomplishments and concerns. Appreciation was expressed. Committee reports are on the KUUF webpage (members' only).

7. **3-Year Strategic Plan Review** (Committee: Elen, Miriam, Lora)

Last approved in 2019. Updated strategic plan is posted on our webpage Serves as framework for Fellowship operation

Strategic Goals:

- 1. Maintain consistent and effective ministerial services.
- 2. Increase size & diversity of Fellowship

- 3. Enhance management and administrative systems.
- 4. Continue & expand caring for each other.
- 5. KUUF members individually and collectively will express through action UU values in the broader community.
- 6. Create space for personal and collective search for meaning.

Cindy motioned and Vicky seconded approval of the Strategic Plan. Unanimously approved, with one abstention.
