- 3. Updates on KUUF bank accounts- Phase 1 of renovations are complete. signers on the bank account need to be updated as capital expenses will come out of the operating account. Strategic Work

1. Building Business

- Air quality John -Treated the carpenting twice with non chemicals. Carol Grafford will get back to John on updates with the Monday morning meditation groups experience. John brought to discussion Considering buying ionizer or ozonator to increase ozone. Considered cost is \$429 and is able to able cover a 4,000 sq ft area. We have \$2,000 donated to address the air quality concerns. Cindy motions to approve the purchase if John feels it is appropriate after online research. Lora seconded. All approved 9
- KUUF building Usage Policy (requests are coming in) Melissa and Elen- 1.
 Document: Building Usage Policy will be sent by email to the board for approval.

- Firearms Policy -Trista-After feedback and minor modification Cindy moves to accept. Elen seconds. All in favor of approving the Firearms Policy 9. Document will be given to Melissa and John for the binder and will be stored in the google docs online
